operated outside of their service areas. Some NPHC OF Tri County Chapters participated and SA is outside of their service area as Chapters and as a NPHC Council.

- NPHC of San Antonio service area is South Texas and Hays County. We overlap with Tri-County in the areas of North Bexar starting in Converse, Live Oak, Universal City, and Selma. We also share Guadalupe, Comal, and Hays County with Tri-County.

In addition, we overlap with the NPHC of Greater Austin in Hays County. All 18 Chapters in this area can choose their NPHC Council but none of the Councils can actively recruit.
